***International Journal of Clinical Legal Education Conference
Monash University, November 28-30 2018***

Since 2013, Monash University Law School has engaged with Faculty from several Universitas Islam Negeri (UIN) on the subject of clinical legal education and, in particular, the Family Law Assistance Programme (FLAP) that has operated at Monash University and at the Dandenong Family Court of Australia for almost 20 years. The FLAP operates as a semester long elective subject that is credited to the student's law degree during which the student provides legal advisory services to women and men bringing their family law cases to court who do not have legal representation. More information on FLAP can be seen at www.monash.edu/law/about-us/legal/flap including a report on a visit to Indonesia facilitated by the Australia Indonesia Partnership for Justice in 2014 by FLAP legal faculty to share their experience of the clinical legal education subjects that may be taken as part of the Monash University law degree. During 2015, Monash University law faculty supported two more training programmes in Indonesia that included UIN faculty and students as well as paralegal staff from the PEKKA CSO. Over the last decade, Monash University has also hosted delegations from Indonesia comprising Indonesian judges and law faculty from several UIN including a visit in 2010 that considered the role of legal aid posts in Court that lead to the Supreme Court Practice Direction SEMA 10 of 2010 (now PERMA 1/ 2014).

In 2018, Monash University celebrates 43 years of clinical legal education and, together with the International Journal of Clinical Legal Education will host an international conference in November of this year:

Unfortunately, we do not have funding to cover the travel costs for international

participants to attend this meeting but very much hope that that it may be possible to welcome you to Monash University.

Cate Sumner has had a paper accepted for presentation at this conference that explores the impact of the collaboration between Monash University and Indonesian universities and the PEKKA CSO since 2014 and the ways that students from both countries as well as CSO paralegals can contribute to their own learning objectives whilst promoting significant improvements for justice seekers in Indonesia and Australia (an outline of the paper is attached). Cate has indicated that she would like to co-present this paper with Dr. Deni Kamaludin Yusuf, MAg, from UIN Bandung to discuss the clients they support at a number of legal clinics in West Java as well as the Director of the PEKKA CSO if funding can be obtained for this within Indonesia. I will be sending a similar invitation to Dr Yusuf as well as the Dean of the Faculty of Sharia and Law at UIN Bandung and remain hopeful that funding may be found for them to participate in this meeting.
